ADM 4162 -DEMOCRATIZATION AND EUROPEANIZATION IN TURKEY

Instructor: Assist.Prof. Canan Akman

Course Description: The objective of this course is to provide for the students of political science a theoretically-informed analysis of democratization in Turkey, with specific

reference to the impact of the Europeanization process. It will emphasize the interplay

between domestic and international forces in Turkish democratization in addition to the

general objective of providing a theoretical framework and a comparative perspective on

democratization to comprehend the challenges of democratization in Turkey. In the first part

of the course, major theoretical approaches and frameworks on transitions from

authoritarianism and consolidation of democracy will be provided. This part will highlight the

various routes, forces and issues and actors of democratization as a background to

comprehend the Turkish case and to put it into perspective. The second part deals with the

Turkish case since the realy 1980s. The discussion on Turkey will proceed through

describing the transition, the political reform process as well as the challenges of

consolidation. The major axis of discussion will be on democratization as the political aspect

of the Europeanization process which was accelerated in Turkey over the last decade.

Course Requirements/Evaluation:

1. It is essential for the students to attend the class regularly. It is also expected that

students come to the class having done the assigned readings beforehand.

2. For class presentations students should prepare notes summarizing the assigned

reading materal (i.e. the presenters should not directly read from the text assigned).

They should summarize the text, higlight its major argument(s) and raise questions for

class discussion

3. All students must understand the meaning and the consequences of cheating,
